

Introduction

Adelaide Expo Hire Pty Ltd. (ABN 14 062 230 433) (**AEH**) respects and upholds your rights under the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) (**Privacy Act**). This Privacy Policy for AEH lets you know what personal information of yours we hold, what we do with it, who we will disclose it to and how you can access the personal information we hold about you. You can also find out here how to change inaccurate personal information and how to opt out of receiving communications from us.

Personal information

How does AEH collect and hold your personal information?

Where possible, AEH will generally collect your personal information directly from you. AEH may also collect your personal information from our venue partners in various circumstances including in relation to our products and services, or from third parties who provide your personal information to us to allow us to contact you regarding potential exhibition opportunities with AEH. We may also collect personal information from our website(s), Facebook or other social media platforms that we operate or establish.

What personal information about you does AEH collect and hold?

The types of personal information that AEH collects from you will be directly related to the specific purpose for which it has been collected. How much personal information that you choose to disclose to us is completely up to you. The only way we know something about you personally is if you provide it to us. However, failure to provide certain information may result in AEH being unable to provide you with the relevant product or service.

The information AEH collects will include:

- If you request information from us directly (e.g. via our website) we may collect information from you such as your name, email address and phone number(s).
- If you make an enquiry, provide feedback or make a complaint to us, we may collect information from you such as your name, email address, phone number(s) and address.
- If you make an application for employment with AEH, we may collect any information that is relevant to such employment including:
 - 1. your name and contact details (i.e. residential address, phone number(s) and/or email address)
 - 2. any other information relevant to the recruitment process (including any information contained in the application form and your resume).

Sensitive information

AEH does not generally collect information defined as 'sensitive information' in the Privacy Act (such as racial or ethnicity information, political associations, health information and criminal records). However, subject to obtaining your prior consent, AEH may collect sensitive information from you in the course of considering your application for employment.

What does AEH do with your personal information?

We will only use and disclose your personal information for the purposes which you provide it or a related secondary purpose which you would reasonably expect. This includes, for example:

- providing the products and/or services you have requested from AEH including for example:
 - 1. designing products to meet unique specifications:





- 2. delivering products or services to you;
- 3. responding to any enquiries, feedback or complaints made by you;
- assessing and administering any applications for employment with AEH.

Who will AEH disclose your personal information to?

AEH may disclose your personal information to:

- other companies or people that we have your consent to share the information with;
- · other members of AEH's related group companies;
- contractors and third party service providers, on a confidential basis, that we use in the ordinary course of our business to assist with the delivery of the product or service you have requested; and

We may disclose your personal information to recipients outside of Australia. AEH is a company based in Adelaide, South Australia. We will take reasonable steps to ensure that your personal information is handled by any overseas recipients in accordance with the Privacy Act and our instructions for the purposes described above. By providing AEH with your personal information, you consent to this disclosure of your personal information.

Openness

You may request access to personal information (including your credit information) we hold about you by contacting the Privacy Officer at the address below. Where we hold information that you are entitled to access, we will endeavour to provide you with a suitable range of choices as to how access is provided (eg, emailing or mailing it to you). A fee may be charged to cover the cost of retrieval.

If at any time you believe that personal information we hold about you is incorrect, incomplete or inaccurate, then you may request amendment of it and we will either amend the information or make a record of your comment, as we think appropriate.

Marketing



We may also share your personal information with our related entities, so that they can provide you with direct marketing communications and material about their products and services. AEH website

When visiting AEH's website(s), the site server makes a record of the visit and logs the following information for statistical and administrative purposes:

- the user's server address to consider the users who use the site regularly and tailor the site to their interests and requirements;
- the date and time of the visit to the site this is important for identifying the website's busy times and ensuring maintenance on the site is conducted outside these periods;
- pages accessed and documents downloaded this indicates to AEH which pages or documents are most important to users and also helps identify important information that may be difficult to find:
- duration of the visit this indicates to us how interesting and informative the AEH site is to users;
- the type of browser used this is important for browser specific coding; and
- in order to optimise the AEH website(s) and better understand its usage, we collect the visiting domain name or IP address, Computer Operating System, Browser Type and Screen Resolution.

The information set out above is collected by automated means including via cookies. A cookie is a piece of information that an internet website sends to your browser when you access information at that site. You can change the privacy settings of your browser, in particular, you can refuse all cookies or opt to be notified each time a cookie is sent to your computer. By blocking or deleting cookies used on our website(s), you may not be able to take full advantage of services offered via our website(s).

AEH also uses other automated devices and website tracking tools such as Google Analytics. Google Analytics is used to collect information about how the AEH website(s) are used. Google Analytics generates statistical and other information about websites by means of cookies stored on users' computers. Google may collect, transfer, store, and process this information on its servers located in the United States. AEH will not use Google Analytics to track or

collect any Personal Information from visitors to our website(s). Retention and destruction of personal information

AEH will destroy or de-identify your personal information as soon as practicable once it is no longer needed for the purpose for which it was collected. However, we may be required by law to retain your personal information after your relationship with us has expired. In this case your personal information will continue to be protected in accordance with this policy. If we destroy personal information we will do so by taking reasonable steps and using up-to-date techniques and processes.

Security of information

AEH will take reasonable steps to protect your personally identifiable information as you transmit your information from your computer to our website(s) and to protect such information from loss, misuse, and unauthorised access, use, modification, disclosure, alteration, or destruction.

However, you should keep in mind that the transmission of information over the internet is not completely secure or error-free. In particular, email sent to or from this website may not be secure, and you should therefore take special care in deciding what information you send to us via email.

Miscellaneous

In this policy personal information has the same meaning as under the Privacy Act.

This policy is effective from 1 July 2025. We may change this policy from time to time. Although we intend to observe this Privacy Policy at all times, it is not legally binding on AEH in any way. From time to time we may regard it as necessary or desirable to act outside the policy. AEH may do so, subject only to any other applicable contractual rights you have and any statutory rights you have under the Privacy Act or other applicable legislation.
